He asked Water Superintendent Umstead if he had anything to add. Superintendent Umstead said that some of the chemical ranges have changed, and we are required to reflect that in our reports. He also stated that people who have a septic service and use our wastewater plant are required to be permitted.

# J. Department Head Reports:

Chief Tucker with Fire Department stated they had responded to 55 calls. 19 EMS calls, party transported by non-fire agency, 5 of medical assist -EMS crew, 5 alarm system activations, 5 dispatched & cancel, 5 aircraft standbys, and various other calls. Chief Tucker had also attached a 1<sup>st</sup> quarter incident report showing 169 responded calls that also proved the importance of the newly organized EMS crew, which includes 18 licensed Fire Department employees and 2 licensed Police Department employees.

Water Superintendent Earnest Umstead stated things were going well with his department. He said the new well was now working very well, and very fortunate to say the new roof on the water department was finished before all the rain showers, we were having now. They had been busy cleaning up around both the water and sewer departments both.

Police Chief White reported his department had responded to 1472 calls this month. The officers had 716 security checks, 179 traffic stops, 90 extra patrols, 72 log informations, 61 ambulance assist, 35 suspicious person and various other calls. All the new trucks were on the road now. The SRO vehicles had new graphics to help identify them.

Public Works Supervisor Johnny Mercer said his crew had been busy cleaning up a lot of the ditches. Hopefully in a few weeks they should be able to start getting some hot mix to fix water cuts and some of the smaller holes They were staying busy running the weekly route pick-ups of household and tree & limbs.

Jim Seaton, Codes Department reported he had thirty-three (33) grass violations since last Friday. He said there had been 3 new buildings put on the condemnation list and 2 properties that had been repaired.

Parks Director Billy Hollowell said the park was in full swing. The soccer league had started on Saturday, girl's jamboree on Sunday. They had been able to remove the old net from the batting cage and replace it. Staying busy with mowing and weed-eating.

# K. Council Reports:

Councilperson Young committed the new sidewalks in the downtown. Said they were very nice and was excited for the new lighting to be installed.

Councilperson Alexandre said he just wanted to let the Fire Dept know he was proud of all their new training and the ES services, shows that we are really working hard for the betterment of our citizens.

Mayor Griffin informed the council that there had been some issues with the quality of the sidewalks along Cedar. Not sure at this time, if it is a result of the concrete mix, or if the salt DOT sprayed caused the issue. It is in the process of having a 3<sup>rd</sup> party opinion on who needs to pay for the replacement.
