L. Department Head Reports:

Public Works Director Johnny Mercer reported they are continuing with household and brush pick up. Mr. Mercer also reported that the traffic light control box @ Cherrywood & 79 went out and will have a \$3300.00 fix. He also stated that the traffic light at Main Street & Cedar is in line to be replaced, as it has been in place since 1978. All the backup batteries on the tornado sirens will be replaced beginning Friday.

Parks & Recreation Director Mike Beasley stated ball season was in full swing from T-ball through high school. Soccer will be beginning this Saturday. Lot of ballfield work, mowing and week-eating.

Codes Enforcer Philip Morrissett informed everyone that mowing season had begun. He also stated that there were several neighborhoods that were progressing well with clean ups.

Water Superintendent Billy Wood reported that the daily routine of fixing leaks was on going.

Police Chief Craig Moates stated the Police Department had a total of 1260 calls for the month. 515 security checks – home / business / parks, 232 vehicles stops, 200 investigations 10-43, traffic control 33, assisting other agencies – 28, Walk-in, talk with officer -28, citizen assist 26, accident/crash – 19, animal control/complaint -18, reckless driver – 11, escort/10-14/ funeral, bank, etc. -10, alarm-burglar / panic / fire 9, assault – 1 and a wide variety of other service calls.

Fire Chief Tucker reported they had a total of 23 incidents during the month of March. 6 of those involved commercial alarms, 5 motor vehicle accident, 4 aircraft stand by, 1 smoke investigations, 2 chemical spill/leaks, 2 brush fire and various other incidents.
