# J. Department Head Reports:

Brian Tucker, Fire Department stated they had responded to 61 calls. 24 medical calls for the month of January, 8 Lift assist, 5 alarm systems activation, 4 aircraft standby, 3 MVA – no injuries, 3 public services, and various other calls. Chief Tucker said the cold weather we had just had was very tough on the crew during structure calls. Chief Tucker mentioned that they had just responded to 8 medical calls this week.

Water Superintendent Earnest Umstead stated with the weather changes we had experienced the ground moves and creates an uptake on leaks, before long we will probably be wide open with leaks. He said that he had moved people around to see who worked well where.

Mayor Griffin said he was thankful for Earnest leadership this past month and bringing them together to work as a team.

Police Lieutenant Brister reported the department had 1,086 calls for service in January. 467 were security checks-home/business/parks, 164 vehicle stops, 87 medical, 86 investigations 10-43, 50 citizens assist and a variety of other calls. He also said the new trucks were almost ready, all have been painted but 2. The department was in the process of getting some new SRO equipment. He also informed us that the Assistant Chief Boucher's father had passed away.

Public Works Supervisor Johnny Mercer said his crew was busy cleaning ditches, since the leaves had finally stopped. He mentioned the backhoe had a valve in the back leaking hydraulic fluid that needed to be repaired; the company would bring them a loaner to use. They were staying busy running the weekly route pick-ups.

Jim Seaton, Codes Department stated that two additional condemned properties had been removed. One on Elm and one on Kay St. He said he is now more involved with commercial properties; specifically, some of the old buildings around the former Gaines building. He had sent about 75 violation letters out, most of them were to repeat offenders.

Parks Director Billy Hollowell said the nice weather had them busy getting fields ready for the upcoming spring baseball season. Middle school was already practicing, high school would be starting next week. They had removed the old backstop and poured concrete in order to put up a 20' net to give more visibility to the field

# K. Council Reports:

Councilperson Young wanted to compliment Jim on a good job with all his work driving through streets and assessing the troubled areas.

Councilperson Armpriest asked how we were doing with the cleanup McKenzie strategy that came up in the workshop. Mayor Griffin said things were progressing.
