J. Department Head Reports:

Brian Tucker, Fire Department stated they had responded to 46 calls. 27 calls for the medical program for the month of December, 5 MVA – No injuries, 2 each for structure fire, aircraft standby, EMS assist, MVA-injuries, and several other. Chief Tucker verified they had received an air pack grant.

Earnest Umstead stated the water department was staying busy. They just hired a new employee, who is young, so hopefully he will be on staff for a long time. Hoping that everything stays in shape for the anticipated cold weather.

Police Chief White, our Drug agent had been assigned to the Drug Task Force. They have had some very large drug bust for marijuana, fentanyl, cocaine and more. Chief White stated he is very happy to have the department working these raids. He thanked the council again for allowing the department to purchase the new vehicles. They are now being outfitted and should be on the road very soon.

Public Works Supervisor Johnny Mercer was welcomed back to work this week after having a hip replacement. He thanked his crew for working hard while he was out. He stated the leave truck had slowed down. They were trimming trees to help the school buses and large trucks. Busy servicing equipment. They had also repaired a downtown sidewalk.

Jim Seaton, Codes Department stated he had been successful in having one house on Forrest demolished and another house on the street a 17,000 lb. cleanup surrounding the house.

Mayor Griffin then congratulated Mr. Seaton about successfully passing the new building code test.

Parks Director Billy Hollowell was not in attendance due to attending an 8th grade award night for one of his grandsons. Mayor Griffin gave Mr. Hollowell's report stating they had removed and packed up all the Christmas decorations. We busy trimming trees at the park and servicing their equipment.

He said that his department had used more Narcan in the past two years, than in the last twenty-three years he had been on the force. With all the drugs, it creates more issues with theft and burglary so they can purchase more drugs. Chief White assured the council that steps were being taken.
