L. Citizens Input: None

M. Department Head Reports:

Water Superintendent Billy Wood reported they were catching up with water leaks. He is still down 2 personnel, but he is working his way down the list.

Public Works Director Johnny Mercer reported they will probably be busy for the next 3-4 weeks picking up brush due to the recent storms. The tractor is still in the shop and the bush hog is down. It will probably take a while to get around.

Fire Chief Brian Tucker reported they had been involved with 33 incidents for the month, which included 5 aircraft stand by, 6 commercial alarms, 5 motor vehicle accidents, 4 brush fire, 3 smoke investigations, and various additional incidents.

Police Chief Craig Moates stated the Police Department had a total of 1291 calls for the month of July. 586 security checks – home / business / parks, 229 vehicle stops, 161 investigations 10-43, traffic control 9, citizen assist 33, alarm-burglar / panic / fire 18, assault – 3 and a wide variety of other service calls.

Park Director Ricky French stated parks still had a lot of mowing to do. There have been lots of limbs and trees down. Summer sports are over, but now getting ready for the fall sports season.

M. Council Reports: Mayor Holland broached the subject of if there should be a permit to shoot fireworks for special celebrations or occasions. Maybe something that says can only be shot from your personal property after the recent fireworks destruction of the pavilion at Mulberry Park. Police Chief Moates stated that some cities have totally abandoned fireworks completely. Chief Moates further stated that sometimes Police do not know sometimes if it is actually fireworks or gun fire until they have investigated. Fire Chief Tucker stated that Bethel University and McKenzie Healthcare are the only entities legally allowed by the ordinance adopted by the City to shoot fireworks. Fireworks are allowed from June 20 through July 5th at this time. It was debated about whether we should amend the ordinance to close the window for selling fireworks July 1-5. We will come back to this after additional research.
