e. Discussion/Approval on 1<sup>st</sup> reading of Ordinance 569 to Convert Broadway Street to a One-Way Street.

Discussion: Mayor Griffin started by apologizing to the council for making the decision contacting them. "In the words of Shirley Nanney, the mayor has learned his lesson" He went on to say that when the engineer approached him with the safety issues of leaving the Street a two-way, he then contacted Police Chief White and Public Works Supervisor Mercer for their thoughts. Both agreed with the engineer, his biggest concern that been the size of the islands. He stated sometimes it is difficult when the engineer and designer are not here when the plans are drawn and after it is underway, you are approached with problems. He asked Supervisor Mercer what the cost would be if it became necessary to restripe and make it two-way again and was told \$ 4600.00. Mayor Griffin said that would not exceed the funds and then reiterated that he had made a mistake and had learned from it.

Councilperson Alexander commented he had personally spoken with business owners and had been told they were fine with it. He also mentioned that the curb was long enough to accommodate a 23' long crew cab pickup. Councilperson Batton said some people don't obey Lee Street period. She felt like it's more change, than how it was approached. She said what mattered is the intent, which she did not feel was that way. Councilperson Young spoke with the downtown businesses as well. He said 13 liked the one way, 3 didn't. He then texted another 15 citizens, and only 3 said no. He said the biggest issue was how it was approached. Some were concerned about the loading zone. He went on to say, he felt the biggest issue of a two-way street was trying to pull out onto Cedar. Councilperson Armpriest said that she felt the general consensus was it didn't matter. She felt like it was not a change in a routine. Councilperson Pruneau stated it was tradition. He has been here since 1965 and it was that way then. Tradition is hard to change. He said to give it serious thought and hear the need. Older people need their say too. Beau Pemberton, the city attorney said both arguments have merit. He said he applauded the mayor for his acknowledgement of being incorrect and suggested to table it to the June meeting and get additional input from businesses and citizens. He stated that people have a tendency to ignore signs, but his role as attorney is what is best change for the entire city. Councilperson Pruneau said a public hearing would be a fair opportunity. Correct a wrong that was a mistake. Councilperson Townes said it was a bad situation, it was good Mayor Griffin he was wrong, but said hard to make a wrong a right.

# J. Department Head Reports:

Chief Tucker with Fire Department stated they had responded to 51 calls.19 EMS calls transported by non-fire agency, 14 of medical assist -EMS crew, 7 alarm system activations, 5 dispatched & canceled en route and various other calls.

Water Superintendent Earnest Umstead stated things were going well with his department. One of the new trucks will used as a service truck. He also mentioned that EPA has issued a test concerning lead & copper service lines being check and finished by October and that his crew has already finished up with the testing.

Police Chief White reported his department had responded to 1444 calls this month. The officers had 774 security checks, 280 traffic stops, and 390 various other calls. One of the new SRO vehicles has been painted with the big M and looks great. He mentioned there were twenty-two (22) vehicles for sale and that they were trying to contact other police agencies to sell them too.

Public Works Supervisor Johnny Mercer said his crew had been busy cleaning up a lot of the ditches. Hopefully next week they will start getting some hot mix to fix water cuts and some of the smaller holes They were staying busy running the weekly route pick-ups of household and tree & limbs.

Jim Seaton, Codes Department reported he had fifty-nine violations. (32) that were one-month old, (2) that are 60 days old, (3) in condemnation process.

Parks Director Billy Hollowell said the park is wide open. Baseball continues. Soccer ends This weekend. Getting ready for a big baseball tournament this weekend. Splash pad opens end of May. The splash pad has new concrete ridge and work on the pump has been finished

City recorder Jennifer Waldrup invited everyone to the Memorial Day program on May 27<sup>th</sup>, Farmers Market opening June 1<sup>st</sup>, Nights on Broadway starting June 7<sup>th</sup>.

Mayor Griffin reminded everyone there would be a Homeless forum at the Park Theatre on May 13<sup>th</sup> at 6 p.m.

Attorney Pemberton said this was his first year as the City Attorney and he had filed delinquent taxes with the delinquent taxes.
