### L. Department Head Reports:

Fire Chief Tucker mentioned that they had been at every game the school sports program was associated. They had worked 36 medical calls, 7 aircraft standbys, 8 system alarm activations, 4-MVA-no injuries, 2 MVA-injuries and several others for a total of 65 calls.

Water Superintendent Billy Wood reported the telemetry equipment was being installed. We said that we were close to the new CDBG grant beginning – bid open will be December 13. other than that, they were doing their regular stuff.

Police Chief White stated that his department had answered 1,236 calls for the month of October. 523 of these were security checks for homes/business/parks, 212 vehicle stops, 92 citizen assist, 84 medical, 75 10-43 investigations, and 250 various assists. He added the new trucks had come in and they had picked up 1 of the pickups that were ordered over a year ago,

the other 3 should be available next week. Southland Graphics in Milan would be doing the logo. We are doing this to all our vehicles because your fleet has to match to be accredited. The grants have helped with the purchase of the vehicles as well. He also mentioned that the new drug dog Toby was doing an excellent job getting drugs off the street.

Jason Wilkes was here to represent the Public Works Department. He stated the department was still in the process of trimming trees that are over hanging the streets. The leaf truck has undergone some work and is ready to run. They are planning to do sidewalk repair on Waldren Street next week.

Parks Director Billy Hollowell stated the backstop at the high school field was in the midst of being repaired. The fencing at the pickle ball was being replaced and paid for by the contractor as it was not the quality it should have been. The department has been doing some pruning. They had a big hollow tree and was fortunate to have Public Works and Carroll Co Electric take the tree down. They are beginning to get the Christmas lights and some décor put up for the upcoming Downtown Christmas Open House.

Jim Seaton reported of the twenty-five violations, ten of them had been resolved. There are also five houses in different levels of condemnation.
